Warranty Claims...

All claims for parts or labor must be made directly thorough Refrigeration X LLC.

All claims should include: model number of the unit, the serial number of the cabinet, proof of purchase, date of installation, and all pertinent information supporting the alleged defect.

In case of compressor replacement under warranty, either compressor or compressor tag must be returned to Refrigeration X LLC along with above listed information.

Failure to comply with warranty policies will result in voiding claims.

Limited Warranty

On-site warranty service calls within 70 miles of an authorized service company in fifty states of the United States. End user is responsible for all extra travel and mileage at prevailing rates. No mileage or travel time is paid.

Two-Year Parts & Labor Warranty...

Refrigeration X LLC warrants all new refrigerated components, the cabinet and all parts, to be free from defects in materials or workmanship, under normal and proper use and maintenance service as specified by Refrigeration X LLC and upon proper installation* (indoor building only) and start-up in accordance with the instruction packet supplied with each Refrigeration X LLC unit. <u>Refrigeration X LLC's obligation</u> under this warranty is limited to a period of two (2) year from the date of original installation or twenty seven (27) months after shipment date from Refrigeration X LLC, whichever occurs first.

Any part, covered under this warranty, that are by Refrigeration X LLC to have been defective within two (2) year of original installation or twenty seven (27) months after shipment date from manufacturer, whichever occurs first, is limited to the repair or replacement, including labor charges, of defective parts or assemblies. The labor warranty shall include standard straight time labor charges only and reasonable travel time, as determined by Refrigeration X LLC.

(*Installation in unstable, mobile, and enclosed area may not be considered as proper installation. Remote units are limited to one-year parts warranty, relative only to original cabinet components. No labor will be covered)

Additional Three-Year Compressor Warranty...

In addition to the two (2) year warranty stated adove, Refrigeration X LLC warrants its hermetically sealed compressor to be free from defects in both material and workmanship under normal and proper use and maintenance service for a period of three (3) additional years from the date of original installation, but not to exceed five (5) years and three (3) months after shipment from the manufacturer. Compressor determined by Refrigeration X LLC to have been defective within this extended period will, at Refrigeration X LLC's discretion, be either repaired or replaced with a compressor or compressor parts of similar design and capacity.

The three (3) year extended compressor warranty applies only to hermetically sealed parts of the compressor and does not apply to any other parts or components, including, but not limited to, cabinet, paint finish, temperature control, refrigerant, metering device, driers, motor starting equipment, fan assembly or and other electrical components, etcetera.

R-290/R-600a Hydrocarbon Compressor Warranty...

The two-year compressor warranty detailed above will be void if the following procedure is not carefully adhered to:

1. This system may contain R290 refrigerant and polyol ester lubricant.

- The polyol ester lubricant has rapid moisture absorbing qualities. If it is exposed to ambient conditions for an extended period, the lubricant must be replaced.
- 2. Drier replacement is very important and must be changed when a system is opened for servicing. Drier with XH-7 molecular sieve or better must be used.
- 3. Micron level vacuums must be achieved to ensure low moisture levels in the system. 500 microns or lower must be maintained.
- 4. Compressor must be obtained through Refrigeration X LLC, unless otherwise specified in writing, through Refrigeration X LLC's warranty department.
